#### **Introduction to our setting's safeguarding children policy statement**

#### **Providing a safe play environment that builds their confidence and self—esteem**

- ┆ Where children can talk and are listened to

- ┆ To make good choices about healthy, safe lifestyles
- ┆ To ask for help if their health or safety is threatened

- ┆ We are committed to developing and maintaining an honest and open relationship with parents and carers
- ┆ We are committed to involving parents and carers at all stages of a child's care
- ┆ Parents and carers understand our setting's safeguarding responsibilities and how we will implement them

#### **Working in an inclusive way that helps every child**

- ┆ To feel accepted and included
- ┆ To fulfil their potential

#### **Working in an integrated way with other agencies that maximizes opportunities for**

- ┆ Early identification of additional needs, early intervention and prevention
- ┆ Speedy intervention based on multi-agency co-operation
- ┆ Common methods of sharing information and assessing need e.g., use of the Common Assessment Framework, Information Sharing, Safetynet+ and the Lead Professional role

#### **Having up-to-date safeguarding policies, procedures and guidance**

- ┆ Based on current national statutory guidance, Sheffield Children Safeguarding Partnership
- ┆ child protection procedures and Early Years Foundation Stage Welfare Requirements
- ┆ Easily accessible to all staff and volunteers
- ┆ Understood and used by all staff and volunteers

#### **Having well trained staff and management who**

- ┆ Recognise their individual responsibilities to safeguard and promote the welfare of all children in their care

- ▮ Receive training and supervision appropriate to their level of responsibility and are clear and confident about what is expected of them
- ▮ Ask for and receive help and support to act on safeguarding concerns
